

Buenos Aires Yoga & Tango Retreat
March 13-20, 2027

Retreat Terms & Conditions

1. To participate in this retreat the full fee is due no later than December 15, 2026. Retreat fees are \$1,850USD for general public, \$1,750USD for on-demand yoga members (who remain members through the time of the retreat) and returning participants, or \$1,650USD for on-demand yoga members who are also returning participants.
2. A full retreat fee refund, minus a \$100USD booking fee, will be available until December 31, 2026, or you may transfer your existing balance to another participant found by you. After December 31, 2026, a retreat fee refund minus your \$900 deposit will be available until January 31, 2027, or you may transfer your existing balance to another participant found by you whose dominant tango dancing role is the same as yours. After January 31, 2027, no refund is available but you may choose to transfer your spot to another participant found by you whose dominant tango dancing role is the same as yours.
3. If Veronika Kruta cancels the retreat for reasons within her reasonable control, participants will receive a full refund of their existing retreat balance. However, no refunds will be issued after the refund deadline for cancellations, disruptions, or changes resulting from force majeure events or other circumstances outside of Veronika Kruta's reasonable control.
4. Veronika Kruta reserves the right to cancel the retreat if minimum participant enrollment required to reasonably operate the retreat is not met. In this event, participants will receive a full refund of their existing retreat balance.
5. The retreat price listed in item #1 above includes 3 tango workshops with taxi dancers taught by Veronika Kruta and invited guest instructors (2 hours each), 2 tango technique classes taught by Veronika Kruta (1 hour each), 5 yoga classes taught by Veronika Kruta (1 hour each), 3 practicas with taxi dancers (1 hour each), 2 milonga outings with taxi dancers (1.5 hours / includes your milonga admission), 1 Q&A session with the teachers (1hr), 1 Asado (Traditional Argentine BBQ), Pre-trip virtual meetup & information session (40-minutes), retreat guide that includes our itinerary, packing list, taxi dancer info, relevant contact info, additional recommendations for milongas and practicas every day of the week, restaurants and cafes, massage therapists, and tango shoe & clothing stores, and site-seeing suggestions.
6. The retreat price listed in item #1 above does not include your airfare, transportation to/from airport, accommodation fee, additional milonga entrance fees, additional meals, taxis and transportation around the city, health-related expenses.
7. Your full room fee (determined by whichever room you reserve at La Maleva Tango Guest House is due upon arrival and paid directly to the La Maleva staff in cash. To reserve your room La Maleva asks for a \$100 non-refundable deposit to be paid via paypal at the time of your reservation.

8. All retreat activities, excursions, classes, wellness offerings, transportation arrangements, and itinerary details are subject to change due to weather conditions, safety considerations, local conditions, availability, or other unforeseen circumstances.
9. Participation in all retreat activities is voluntary.
10. Participants reserving shared accommodations are welcome to register with their own roommate or request roommate matching assistance.
11. While every effort will be made to thoughtfully pair participants based on compatibility and preferences, roommate compatibility and specific requests cannot be guaranteed.
12. Room selections and accommodation categories are reserved on a first-come, first-served basis and are subject to availability. Requests to change room categories, occupancy type, or roommate arrangements after confirmation may not be possible and cannot be guaranteed.
13. You voluntarily agree to take full responsibility for any loss or damage of personal property occurring from the time you leave your home to the time of your return from this retreat, and to release, waive, and discharge Veronika Kruta and any persons hired by Veronika Kruta or accommodation/venue facilities associated with this retreat from liability for any claims made by you.
14. You voluntarily agree to take full responsibility for any personal injury, illness, allergic reaction, or other health-related issue incurred through participation in any activity or consumption of any food or beverage during this retreat, and to release, waive, and discharge Veronika Kruta and any persons hired by Veronika Kruta or accommodation/venue facilities associated with this retreat from liability for any claims made by you.
15. You are fully aware of the risks and hazards involved and recognize that the activities on this retreat may require physical exertion that could be strenuous and may cause physical injury. You understand that it is your responsibility to consult with a physician prior to and regarding your participation in any activities associated with this retreat.
16. Veronika Kruta shall not be held responsible for delays, cancellations, losses, injuries, additional expenses, or changes caused by events beyond her reasonable control, including but not limited to weather events, natural disasters, travel disruptions, airline cancellations or delays, venue closure, government restrictions, illness outbreaks, political instability, transportation interruptions, serious illness, injury, family emergency, or other force majeure circumstances affecting retreat participants, retreat staff, or Veronika Kruta herself.
17. No refunds will be issued after the refund deadline due to force majeure events or other unforeseen circumstances outside of Veronika Kruta's control. For this reason, travel insurance that covers the full cost of the retreat as well as airfare and travel-related expenses is strongly recommended.
18. Veronika Kruta may recommend travel insurance providers but shall not be held responsible for any error made on the participant's part in selecting insurance coverage that does not adequately cover retreat-related expenses or cancellations.
19. In the event that you cancel your participation after the refund deadline and your travel insurance reimburses your retreat fee, any replacement participant found by you will still be responsible for submitting full retreat payment independently.

Veronika Kruta reserves the right to make changes to the retreat itinerary, accommodations, schedule, instructors, excursions, classes, or services as necessary due to unforeseen circumstances or factors outside of her control. Every effort will be made to preserve the quality, integrity, and overall experience of the retreat.
21. You voluntarily agree to allow Veronika Kruta to use photographs, video, testimonials, or feedback taken during the retreat for marketing and promotional purposes.
