## Terms & Conditions / Liability Waiver

- To reserve your spot for this retreat a deposit of \$900 USD must be received along with your registration form. To participate in this retreat the remaining balance is due no later than January 14, 2026. Full retreat fees are \$1,915 USD for the general public, \$1,815 USD for on-demand yoga members (who remain members through the time of the retreat) or returning participants, or \$1,715 USD for on-demand yoga members who are also returning participants.
- 2. A full refund, minus a \$100USD booking fee, will be available until February 14, 2026, or you may transfer your existing balance to another participant found by you. A refund of your full fee, minus the \$900 deposit is available between February 14 and February 28, 2026, or you may transfer your existing balance to another participant found by you. After February 28th, 2026, no refund is available but you may transfer your existing balance to another participant found by you. If Veronika Kruta and Diana Cruz cancel the retreat at any time you will receive a full refund of your existing balance.
