Retreat Terms & Conditions

1. To reserve your spot on this retreat, your completed registration form and \$1000usd deposit payment must be received.
2. To participate in this retreat, the remainder of your full retreat fee is due no later than **November 10, 2026**.
3. Your full retreat fee is based on your selected room category and is listed in USD:
 - Cozy Shared — \$2,470
 - Select Shared — \$2,670
 - Signature Shared — \$2,820
 - Premium Shared — \$2,920
 - Select Private — \$3,620
 - Signature Private — \$3,870
 - Premium Private — \$4,270
4. Until **November 15, 2026**, a full retreat fee refund minus a \$100USD booking fee will be available, or you may transfer your existing balance to another participant found by you.
5. From **November 16 – December 1, 2026**, a full retreat fee refund minus your deposit payment will be available, or you may choose to transfer your spot to another participant found by you.
6. After **December 1, 2026**, no refunds will be issued. However, you may choose to transfer your spot to another participant found by you.
7. If Veronika Kruta cancels the retreat for reasons within her reasonable control, participants will receive a full refund of their existing retreat balance. However, no refunds will be issued after the refund deadline for cancellations, disruptions, or changes resulting from force majeure events or other circumstances outside of Veronika Kruta's reasonable control.
8. Veronika Kruta reserves the right to cancel the retreat if minimum participant enrollment required to reasonably operate the retreat is not met. In this event, participants will receive a full refund of their existing retreat balance.
9. The retreat price listed above includes:
 - 5 tango workshops (1.5 hours each)
 - 5 yoga classes (1 hour each)
 - 1 scheduled beach trip with transportation to/from the retreat venue included
 - 1 private catamaran bay tour with transportation to/from the retreat venue included
 - 1 waterfall hike with transportation to/from the retreat venue included

- 1 cacao ceremony and facilitated intuitive dance journey
- All meals from the time of arrival to departure from the retreat venue, including light buffet breakfasts, brunches, and dinners
- 2 Tango Women's Circles (1.5 hours each)
- Transportation to and from the retreat venue for one bachata club outing
- Group shuttle transportation to and from Santo Domingo Las Américas International Airport within the suggested arrival window
- A pre-trip virtual meetup & information session (45–60 minutes)
- A retreat guide including itinerary, packing list, relevant contact information, individual wellness and bodywork session information, and additional retreat details

For members of my On-Demand Yoga Membership, a complimentary 1-hour private tango lesson is also included (a \$120 value, subject to availability). To be eligible, you must remain an active member for a minimum of 3 months prior to the start of the retreat and through the duration of the retreat.

9. The retreat price listed above does not include:
 - Airfare
 - Individual transportation to/from the airport if arriving outside of the suggested arrival window
 - Additional meals or extra nights booked at the retreat venue
 - Taxis or transportation around town for individual activities outside of the retreat itinerary
 - Optional private tango lessons (except where included through membership eligibility)
 - Optional wellness or bodywork sessions
 - Alcoholic beverages
 - Health-related expenses
 - Travel insurance
11. All retreat activities, excursions, classes, wellness offerings, transportation arrangements, and itinerary details are subject to change due to weather conditions, safety considerations, local conditions, availability, or other unforeseen circumstances.
12. Participation in all retreat activities is voluntary.
13. Participants reserving shared accommodations are welcome to register with their own roommate or request roommate matching assistance.
14. While every effort will be made to thoughtfully pair participants based on compatibility and preferences, roommate compatibility and specific requests cannot be guaranteed.
15. If a roommate match is not available due to group numbers, a private room upgrade at a reduced supplemental rate may be offered, subject to availability.
16. Room selections and accommodation categories are reserved on a first-come, first-served basis and are subject to availability. Requests to change room categories, occupancy type, or roommate arrangements after confirmation may not be possible and cannot be guaranteed.
17. You voluntarily agree to take full responsibility for any loss or damage of personal property occurring from the time you leave your home to the time of your return from this retreat, and to release, waive, and discharge Veronika Kruta and any persons hired by

Veronika Kruta or accommodation/venue facilities associated with this retreat from liability for any claims made by you.

You voluntarily agree to take full responsibility for any personal injury, illness, allergic reaction, or other health-related issue incurred through participation in any activity or consumption of any food or beverage during this retreat, and to release, waive, and discharge Veronika Kruta and any persons hired by Veronika Kruta or accommodation/venue facilities associated with this retreat from liability for any claims made by you.
19. You are fully aware of the risks and hazards involved and recognize that the activities on this retreat may require physical exertion that could be strenuous and may cause physical injury. You understand that it is your responsibility to consult with a physician prior to and regarding your participation in any activities associated with this retreat.
